## NOTICE OF GENERAL MEETING (AT A NEW PLACE):

There will be a general meeting of the C.C.N.A. on Tuesday evening,

June 23, 2009 at 6:30 p.m. at MARYCREST MANOR

THAT'S RIGHT...MARYCREST MANOR!!! It sits at the very top of Culver Crest. Have you ever visited Marycrest Manor? Do you know the history of this great place? Do you know what services it provides today? Did you even know it was there? Come check out the fabulous view from this historic place, walk through its gardens and hear all about its history. Our guest speaker, Anna Taylor, Administrator of the Manor, will tell us all about Marycrest Manor. Just go up Cranks Road to the very top and turn right. It's hard to miss!

NOTE: Weather permitting, this meeting will be outdoors next to the swimming pool. Be sure to bring something warm to wear in case it gets cool.

This meeting will cover the current issues impacting Culver Crest residents. We conduct these meetings in the town hall style: anyone can raise their hand and be recognized to voice an opinion. As always, any topic of interest submitted by any Crest member will also be discussed.

#### PXP OIL FIELD:

Last October the County Board of Supervisors adopted an oil field zoning overlay called a Community Standards District (CSD) and certified an Environmental Impact Report (EIR). Representatives of C.C.N.A. worked long and hard on this legislation, and while there are a lot of good things that were accomplished, there were also some serious deficiencies with the process.

As a result, four lawsuits were filed, including one lawsuit that includes Mark Salkin, board member of the C.C.N.A., as a representative party and Ken Kutcher, also a Culver Crest resident, has volunteered to serve as his attorney. One of the other four suits was filed by the City of Culver City. The four lawsuits have now been consolidated into the same courtroom with the same judge. The trial for all four cases is scheduled for November, 2009.

In the meantime, PXP is processing applications to renew their drilling operations. The State Division of Oil, Gas and Geothermal Resources (DOGGR) has just issued permits for PXP to drill four new wells. But PXP cannot proceed with drilling until the County's review of those applications is completed and until the County's new regulations are in place. John Kuechle, yet another Culver Crest resident, is on the Community Advisory Panel (CAP) that is established under the CSD. John has been active in commenting on PXP's drilling plans to make sure they comply with the CSD and with keeping us informed of all activities with this issue

As a reminder, if you smell odors or hear construction (e.g., drilling) noises that are not within the normal operational hours that you think may be coming from the oil fields, you are urged to call the AQMD at 1-800-CUT SMOG immediately. They will come out to investigate your concerns. In addition, please email the information you reported to Los Angeles County at Ifreeman@planning.lacounty.gov (phone number 213-974-6453-Leon Freeman) and call PXP at 800-766-4108-Lisa Paillet). It is important to contact all three parties in order for this program to be effective. It is also important that your neighbors know that you are experiencing these disturbances and essential for the C.C.N.A. Board to know so we can follow up with any complaints. In addition, Los Angeles County has released the PXP Landscape Plan. The Plan shows that PXP currently proposes to do no landscaping at all on the Culver City side of the oil field (Please go to our website at www.CulverCrest.org to see the plan and the letter John Kuechle wrote objecting to the plan). While this is far from the top priority issue with respect to oil field operations, we are outraged by the "fast one" that recently retired Los Angeles County Supervisor Yvonne Burke pulled. She promised complete camouflage of the unsightly oil field equipment. In fact, complete landscaping seemed to be her major emphasis and the one accomplishment she apparently was most proud of.

We are continuing attempts to have County staff revise the proposed landscape plan to include our end of the oil fields. Unfortunately unless there is a significant public outcry, the Plan will be probably be approved. Therefore, if any of you think this issue is worth pursuing, you should send comments to Leon Freeman at the County Department of Regional Planning by calling him at 213-974-6453 or emailing him at Ifreeman@planning.lacounty.gov. Unlike many of the oil field Plans that are being reviewed by the County, this one does not require any particular expertise to submit a set of comments or objections. Does the current appearance of the oil field (as viewed from Culver City) bother you? If so, tell the County.

### CRIME REPORT:

We are disturbed to report that there have been several house burglaries committed on and adjacent to the Crest. We are very sorry to those residents who were victimized and hope all is reasonably back to normal.

We are very pleased to report that the criminals were apprehended. With assistance from our vigilant neighbors, the Culver City Police Department who responded with their usual zeal and dedication to the job were able to apprehend these guys. They were actually caught in the act of another one of their 'missions' at the intersection of Overland and Ranch. The capture took place only because one of our neighbors IMMEDIATELY called the Culver City Police Department and reported suspicious activity. These guys were previously seen in their white Mercedes SUV casing the neighborhood and were reported to the police by several residents.

Analysis: Crest homes still sell quickly due to demand. There has been more inventory this year than in previous years. Time on the market is short. There is a large buyer demand as shown by 33% of sales resulting in prices over the asking prices. Escrow prices are not reported until closing.

#### WATER RATIONING:

The Golden State Water Company (which covers our area) filed a Notice with the California Public Utilities Commission (CPUC) to institute a staged mandatory rationing plan. The company proposes seven stages of mandatory conservation and rationing ranging from cutting back 10% to 50% water usage depending on severity of the drought. Each customer's baseline comes from averaging your 2004-2006 usage.

Stage one is voluntary and carries no penalties. Once approved by the CPUC, you can be penalized for overages and fined \$50 to \$300 depending on the conservation/rationing stage.

The Notice they have prepared defines 16 conditions that will bring about penalties. These are much too long and complex to include here. You can call the Golden State Water Company at 1-800-666-4033 and have them send you the Notice or go to their website (www.gswater.com) for more information.

We will be discussing this rationing plan at our general meeting Tuesday.

#### ANNUAL MEMBERSHIP DUES:
